

Timeline for Reconveying/Conveying Process

Decide To Do it !

Choose appropriate paperwork

Collect info – Birth Certificate,
parents wedding date

Obtain registered Post labels for all envelopes

Metes and Bounds survey any Property

If married. Get autographs of
Celebrant and witnesses

**Registered Post Tracking Number of Letter to Self becomes thy Recording Number
Put on footer of every page of every letter ye send**

Enter thy details into Paperwork

Red = personal information – change to black before printing

Green = instructions – Delete before printing

Check Paperwork Thoroughly

Book Notary Appointment for Autographing paperwork

Scan for records, Get copies of all paperwork certified as a true copies

Post 1st letter to Self

Delivery Date = Proclamation Date

Post 2nd letter to Self – Keep Both Letters to Self safe and **unopened**

Day 30

Publish newspaper advert 1

Day 60

Publish newspaper advert 2

Collect 10+ copies of each publication

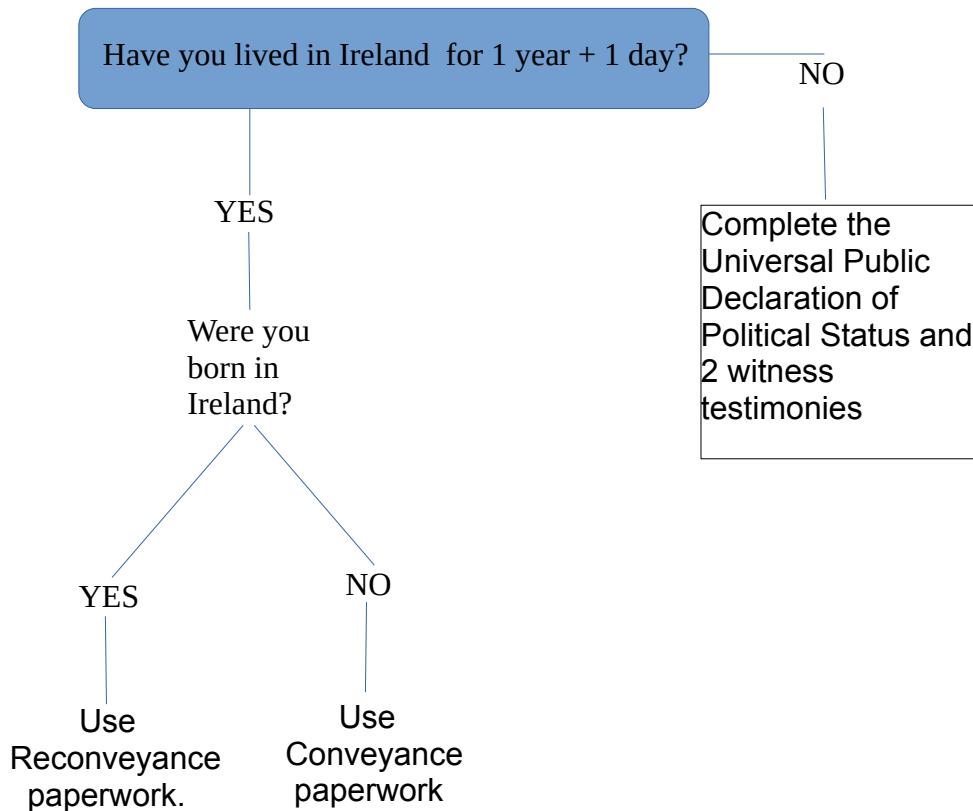
Most protection



1. 928 package witnessed by Notary Public
2. 928 package witnessed by 3 individuals
3. 928 package witnessed by International Notarial witness
4. Basic package witnessed by Notary Public with additional fee schedule, published and posted to self.
5. Basic package witnessed by 3 individuals with additional fee schedule, published and posted to self.
6. Basic package witnessed by International Notarial witness with additional fee schedule, published and posted to self.
7. Basic package witnessed by Notary Public not published
8. Basic package witnessed by 3 individuals not published
9. Basic package witnessed by International Notarial witness
10. Basic package witnessed by 2 individuals

Minimum needed to open Global Family account

Note: Using living witnesses is not recommended for people with existing and ongoing issues with the occupying court system.



Instructions for full 928 Package

Declare, Record, Publish

List of Documents that need to be Notarised or Witnessed by 3 people or an Assembly International Notarial Witness

For the standard 928 package the base documents are listed below. These need to be signed in front of the Notary, 3 Witnesses or an Assembly International Notarial Witness

Acknowledgement, Acceptance and Deed of Reconveyance/Conveyance
Certificate of Assumed Name
Act of Expatriation (3 for each change of family name)
Cancellation of All Prior Powers of Attorney (1 for each change of family name)
DNA Notice of Paramount Claim
Foreign States Immunities Act/Mandatory Notice
Declaration of Political Status
Witness testimony Affirmation (x2)
Living Testimony in the Form of an Affidavit (LTA) (1 for each respondent)*
Fee Schedule (1 for each respondent plus 1 generic)**

*There will be 6 respondents (7 in Northern Ireland) so you will have 1 Living Testimony documents (6 docs [7 docs in NI]).

**There will be a Fee Schedule doc for each respondent plus 1 to "All Entities" (7 docs [8 docs in NI]).

Certificate of Mailing for every letter/notice you send
 Notice of Praecipe
 Notice of Tacit Agreement and Agreed War Crimes
 Newspaper advertisement

(1) Purchase an anpost/royal mail large letter (A4) tracked and signed post label – This tracking number is your Recording Number

Purchase anpost/royal mail tracking labels:

- one for 2nd letter to your self
- one for each son/daughter’s recording number
- one for each property
- two labels for each respondent.

(2) Customise Reconveyance/Conveyance documents to yourself by only changing the red text which is information about yourself and the respondents and then change colour to **Black** before printing

Green text is instructions – DELETE before printing

Enter recording number in footer of every page of paperwork you send to anyone.

For documents with more than 1 page, print on both sides of paper.

(3) Autograph with correct pen colour in front of a Notary Public or 3 witnesses, or an Assembly International Notarial Witness.

(4) **Important** - Scan original documents for your records
 To make it easy when uploading to Global Family Group Recording and Publishing system, scan the documents as pdf files, grouped as:

1. Witness 1
2. Witness 2
3. Witness 1 and 2 together as one file
4. Declaration of political status
5. Fee schedules.
6. Common Carry declaration (Gun licence)
7. Remainder of 928 documents

you will need a high quality head and shoulders passport quality photograph of yourself as jpg file

Also scan they red thumbprint and save as a jpg file

(5) Copy each document; one for each respondent plus at least 1 of each for your own records.

So each respondent gets a copy of:

- Their own personalised Living Testimony as Affidavit
- Their own personalised fee schedule
- Their own personalised praecipe, plus
- a copy of every other document of the 928 package (but not birth certificate)

(6) Get **all copies** certified as a true copy of the original.

For every letter posted, make sure you include a certificate of mailing autographed by an independent man/woman.

(7) Post Letter 1 to thyself:

in a sturdy (poly mailing bag) envelope addressed correctly to correctly to your legal persona self. ** address in CAPITALS, stamp with you autograph across it, return address Proper Style, [] around postcode. ** **Use red ink – from the living man/woman**

(8) When you receive letter do not open it..keep it in a safe place - **Important do not open this letter.** The only person to open this (if ever needed) will be a judge, solicitor, police. If they open it, they assume all liability for your legal persona. Date you receive the letter becomes Proclamation Date.

(9) For other applicable documents, post to your legal persona self originals of:

Deed of Land Recording (for offspring under 21years)
Proclamation of Lawful Marriage
Common Carry – Gun License
Documents for property ownership
Certificate of Mailing

For couples - you can put these all in one envelope.

(10) Enter Proclamation Date into Notice of Praeipice and Notice of Acceptance
Mutually/Tacitly agreed War Crimes. Also Notice of Acceptance after newspaper adverts
finished

(11) Upload scanned documents to Global Family Group Recording and Publishing system
at <https://globalfamilygroup.com/lrps.html>

choose '**status corrected**' Box in the middle of webpage (from menu if on mobile)
Complete the secure form
For type of identification – choose 'other' (or choose Government issued ID if you desire)
ID Number – enter your recording number
Click "Submit"

All info is sighted by a volunteer recording secretary, so you will receive account details via
email. Please be patient as this may take a few days.

When you receive login details, upload as separate files:

- ID (Both witness statements as one file or Government ID) pdf or jpg
- Declaration of political status pdf
- Witness 1 pdf
- Witness 2 pdf
- Fee schedule
- Common Carry declaration (if applicable)
- Remaining 928 documents pdf
- Proof of address – Image of a letter you received through postal system, utility bill, bank
statement etc pdf or jpg
- Passport quality photo (head and shoulders) jpg
- Thumbprint image jpg

(12) Send certified copy of all applicable paperwork to each respondent via tracked and
signed post: (day 0) - Make sure to keep records of all tracking numbers posted

Deed of Land Recording (for offspring under 21 years)
Proclamation of Lawful Marriage
Common Carry – Gun License
Documents for property reconveyance

(13) Book newspaper advert to publish locally the first advert on day 30,
Depending on the publication cycle, publish the 2nd & 3rd adverts on days 60 and 90 or for
the next 2 months (if monthly publication) or the following two 4 weekly cycles
Do not have a box around text.
Obtain 10+ copies of each publication as the whole page of each advert may be used at a
later date.

(14) Day 30, Send to respondents via tracked and signed post:

Notice of Mutually/Tacitly agreed War Crime War Crimes
Certificate of Mailing

(15) After day 120

Complete Notice of Re/conveyance and autograph in front of Notary or 2 witnesses
Make several copies and get them certified as true copies to send to bank, council, etc

Congratulations, you have fully Reconveyed/Conveyed

(16) Send letters to Foreign Secretary(s) with instructions to add your name to 'do not
detain' lists and remove your name from taxes, registrations etc
